Summary and Future Initiatives

- November 2020, the PPA has 45 EV spaces across 4 garages and the Second Avenue Plaza Lot. Twenty-six (26) of these chargers are networked and available for public access.
- The Public Parking Authority is continuing its partnership discussions with **Duquesne Light** for future EV installations. Discussions currently involve adding additional EV spaces at the Authority's Ft. Duquesne & 6th St. Garage.
- The Authority is also in discussions with the City of Pittsburgh to expand the number of EV chargers at the Second Avenue Parking plaza to enable the City to further electrify their Permits Licenses and Inspections (PLI) and Dept. of Public Works (DPW) fleets. Current discussions include adding approximately sixteen (16) dual EV chargers in the Second Avenue Plaza lot.
