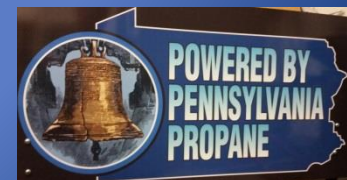

# MTSA Serves Northern Allegheny County

- 52,000 Residents – All or parts of 7 Communities
- 44 Square Mile Service Area
- 21 Pumping Stations
- 4 Wastewater Treatment Facilities
- Over 400 miles of sanitary sewer lines
- 50 + Employees

- Promote Propane as our alternate Fuel Source

- Emphasis on freedom of foreign oil prices
- Convert two to three existing newer vehicles

- Communication is the key to Success



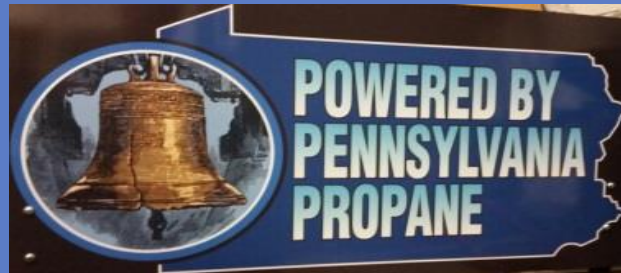


## 1000 Gallon Propane Storage Tank & Dispensing Pump

The Authority decided in 2014 that it would be best for the Authority to have its own fueling station on site. We have both diesel and gasoline storage tanks and pumps already; with the nature of our business, it was felt that having access to fuel on a 24 hour – 7 day a week basis was important. The decision to move in this direction became very easy when our research revealed that we could lease an above ground storage tank and pump for a minimal fee. Our only responsibility was to provide the required electric supply and install a fuel pad that meets the standard requirements for propane fueling. This whole process was well under \$16,000.00. Although our propane fueling station is for our private use, we have offered to allow our neighboring governmental agencies/ municipalities the option to fuel here should they began a propane program of their own. We also have other propane powered equipment, such as forklifts, that prior to having the fueling station had to have their tanks fueled elsewhere.

## Key Notes:

1. Pro Gas monitors our system & makes deliveries on a routine basis
2. Dispensing system was able to be tied into our current fuel logging system to track usage
3. MTSA maintains system with assistance from Pro Gas
4. Propane continues to remain at least \$1.00 less than gasoline
5. Propane serves as an alternate fuel source if shortages occur with gasoline
